CAREER SURVIVAL: SOCIAL NETWORKING & DIGITAL COMMUNICATION

Lesson Purpose: To familiarize the student with the practices and procedures of social networking in the context of career survival.

Training Goals/Objective: At the end of this block of instruction, the participant will be able to achieve the following objectives in accordance with the information presented during the instructional period:

1. Differentiate between “social networking” and “digital communication”
2. Articulate the applications for various social networking sites and digital communication platforms
3. Illustrate the professional consequences of unethical and/or prohibited behavior via social networking and digital communication
4. Outline recent court decisions relating to social networking and digital communication
5. Given a model policy, revise it for implementation in student’s agency
6. Relate other policy areas which may be impacted by social networking and digital communication on duty
7. Compare and contrast the benefits and consequences of allowing/not allowing social networking and digital communication by employees
8. Given the topic “allowing social networking and digital communication in the criminal justice community”, develop an argument for debate

CAREER SURVIVAL: COMPUTER FORENSICS OVERVIEW (INTERNET FORENSICS AND INVESTIGATIONS - IFI)

Lesson Purpose: Use the internet to your investigative advantage

The IFI course will focus on using Internet artifacts to your tactical advantage during an investigation by answering the following questions:

1. How can investigators use the information found on the internet in their cases?
2. How can the internet be used during covert investigations?
3. Is it possible to remain anonymous on the internet?
4. How can I obtain identification information from different internet service providers?

Training Goal/Objective: Using a realistic case scenario, built on a Windows 8.1 Operating System, the IFI course takes an in-depth look at difference tools available to answer these questions and provides best practices to enhance the ability of investigators to use internet artifacts and information to their advantage during any type of investigation. Seven competency areas addressed:

1. Network Fundamentals – Home wireless networks
2. Internet Forensics
3. Email Tracing
4. Cooperation with international service providers
5. Cloud services + P2P/Instant messaging
6. Social media in investigations
7. Covert investigations
